Rate Class – This identifies the RCMU rate used to calculate the bill. Additional information regarding your rate can be found in the current Rate and Tariff section.

Account Information – Each customer has two types of identification numbers. The ACCOUNT number is associated with the service location and meter. The CUSTOMER number is specific to the business or person that established the account

Summary of Current Charges – The electric charges for the billing period are here. A description of common transaction types is listed below.

Energy Charges are for total kilowatt-hours (kWh) consumed during billing period.

Demand Charges are based on peak demand and are applied to certain rate classes. The peak demand is the highest amount of electricity used during a defined time interval, typically over a full hour.

Facilities-Related Demand charge is billed on a per-kW basis and is charged each billing period throughout the year. It is applied to the greatest amount of registered demand in each billing period. This charge is necessary to recover costs for the installed transmission and distribution facilities to serve your highest demand during the year.

Time-Related Demand charge is applied only during the summer season. It is a per-kW charge and is applied to the greatest amount of registered demand in each summer season billing period. This charge helps recover part of the higher costs of providing service during the high demand summer season.

Customer Charge covers a portion of basic services such as bill preparation, meters, meter reading, and customer service.

State Electric SurTax – The Energy Resources Surcharge was established in 1975 by the State of California to fund the California Energy Commission. All electric utilities in the state must collect and remit to the State Board of Equalization the amount of the applicable surcharge. The current surcharge is \$0.00030 per kWh.
